They welcome all, provide free books and services to help individuals and communities, and they offer a venue for people from all backgrounds to come together to discuss, debate, and learn from one another.

Indeed, The New York Public Library has been a haven for New Yorkers of all ages and from all walks of life for more than 100 years—providing much-needed free programs and resources that improve lives and strengthen communities. As you will see in the pages ahead, patrons throughout the city rely on the Library for access to the tools and information they need to succeed and thrive in today's world.

Across our branches, users such as Alina (p. 3) depend on our early literacy services to give their children the best start possible. At Washington Heights Library, a new Teen Center means that María (p. 8) and other local youth have somewhere safe and engaging to go after school. And across the city, readers of all ages—including young Enoch (p. 11)—are finding it easier than ever to access the books they need, both in our branches and online, with our new free e-reader app, SimplyE.

At the Stephen A. Schwarzman Building, we reopened our iconic Rose Main Reading Room following a major restoration, allowing scholars and writers such as novelist Álvaro Enrigue (cover), to once again discover our collections within the awe-inspiring space. "Here you can read the whole world. You have a universe of sources," says Álvaro, a former Cullman Fellow. And at the Schomburg Center for Research in Black Culture, we continued work on a large-scale renovation that will feature an updated façade and auditorium, new reading rooms, and other amenities upon its expected completion in summer 2017.

Of course, this work wouldn't be possible without both public and private support at all levels. As we prepare for the next fiscal year, we encourage our many and diverse supporters to invest in their fellow New Yorkers by investing in libraries, so that we can continue to improve lives and communities across our great city and beyond.

The past year has been a time of renewal at The New York Public Library's four research centers. In fall 2016, we celebrated the return of researchers to our celebrated Rose Main Reading Room following a major restoration, while we also strengthened services at our other renowned locations, fulfilling our century-old dedication to scholarship.

Preserving a Masterpiece

One of the year's crowning achievements, the Library's Rose Main Reading Room at our Stephen A. Schwarzman Building reopened to the public in October following a twoyear, \$12 million restoration that included reinforcements to the Reading Room's majestic 52-foot-high ceilings and a recreation of the ceiling mural in the Bill Blass Public Catalog Room. The reopening of these historic spaces—which have served scholars and writers for more than 100 years—has restored full research capacity at our most heavily used center, while heralding other improvements for the many students and scholars who rely on our collections.

In spring 2016, the Library completed construction on the second level of the Milstein Research Stacks beneath Bryant Park. This state-of-the-art storage was made possible by a generous gift from Library Trustee Abby S. Milstein and her husband Howard P. Milstein and creates the capacity for more than four million volumes at the Schwarzman Building. We also installed a modern conveyor system to efficiently carry materials from storage to the Reading Room. "NYPL is the greatest public research library in the world, precious to all of us who care about the life of the mind," says William P. Kelly, who joined NYPL in early 2016 as the

Across Our Research Centers

Over the past year, the Library continued to preserve and grow our collections. At 42nd Street, the original Winnie-the-Pooh dolls returned after a year of conservation work, and we added *The New York Review of Books* archive—over 1,200 linear feet of key manuscripts—to our collections. The Library for the Performing Arts also acquired many notable items, from the Dance Division's first hip-hop collection to rare, first-edition music from Handel.

At the Schomburg Center for Research in Black Culture, we will be wrapping up a large-scale renovation in summer 2017 that will bring an updated façade, new reading rooms, and other amenities when completed. The Schomburg also recently named a new director-awardwinning poet and scholar Kevin Young. At our Science, Industry and Business Library, the 2016 StartUP! Competition attracted a record number of business plans. Winners included Noëlle Santos, who aims to open the Bronx's only independent book shop, and an eco-friendly water distribution service, Reefill.

PRESERVING OUR AUDIO & MOVING IMAGE COLLECTIONS



The Library's audio and moving image collections are a vast treasure trove housing some of the most important multimedia recordings of the 20th century. Yet, a recent assessment made possible by The Andrew W. Mellon Foundation found that—due to their formats more than 200,000 of these materials are at risk of being lost forever to decay or obsolescence.

The Library has already rescued thousands of these items. But many recordings, primarily found at the Library for the Performing Arts and the Schomburg Center, are still at risk. Over the next year, NYPL seeks to raise \$50 million to preserve and make accessible these historic records so they will continue to inspire future generations.

EDUCATION

Our early literacy programs provide young children with the language skills they need to succeed in school.

The New York Public Library is the city's largest provider of free educational services and resources for all ages. From story times and academic support for our younger patrons to English classes, tech training, and job search help for adults, our programs change lives and ensure equal access to opportunities for all New Yorkers.

Literacy for the Whole Family

One area of particular focus for the Library is early literacy. With research showing that half the achievement gap between highand low-income families starts before kindergarten, the Library is committed to bridging this divide by providing equal access to reading and literacy support to our youngest users.

We are in the midst of a major early literacy expansion that has brought enhanced services to families in more than 50 branches. As part of this initiative, we have also hired more than 40 new children's librarians, who receive training that combines children's librarian expertise with early childhood education. Overall, we have increased children's program offerings by more than 20 percent to meet the surging demand for services. In addition to helping budding readers, NYPL's new Family Literacy branches connect parents with additional tools and resources to help them succeed, from English language classes to job search resources and more. "The Library's programs have been great for my whole family," says Asma, above, who visits Mosholu Library in the Bronx every week with her one-year-old, as well as with her husband and older daughter.



Expanded Outreach

Bringing our educational services beyond our branches and out to New York City communities is a growing priority. Over the past year, we increased outreach to schools, doubling class visits to more than 12,200. We also provided twice as many teacher sets through MyLibraryNYC, our partnership with the Department of Education that connects schools with library books. The Library is also seeking new ways to bring our resources to homeless families. We now provide library services to seven local shelters and aim to double that number in the coming months. Through the program, visiting librarians offer read-alouds, after-school STEM classes, and early literacy workshops.

ENSURING DIGITAL EQUITY



The Library remains committed to bridging the digital divide through free tech programs and services. In 2016, we doubled seats in our popular Project Code program and added 350 spots in new series courses in graphic design, 3D printing, and coding for kids and teens. "Because of Project Code, I feel confident. I can take on the world now," says Belinda, above, a Mid-Manhattan Library student.

NYPL also continues to seek new ways to extend technology access beyond its walls. Thanks to renewed investment from Google, the Library's HotSpot program relaunched to provide free home internet to New York's public school students in partnership with the Department of Education.

In fall 2016, the Library opened a vibrant new Teen Center at Washington Heights Library in Manhattan using formerly vacant space on the branch's top floor.

Thanks to increased public and private support, The New York Public Library is in the midst of a major reinvestment in its libraries. With many of our branches dating to philanthropist Andrew Carnegie's historic library expansion 100 years ago, the funding will allow us to meet the needs of our users of today and tomorrow—though more is needed.

Keep Investing in Libraries

There is no doubt that the need for our libraries is growing—and changing. More New Yorkers than ever before rely on the Library for a broader range of services than ever, from afterschool support for students to training in the computer skills needed for today's workforce. These growing demands require increased capital investment to keep our branches in good repair while addressing chronic maintenance needs caused by decades of insufficient funding. It also requires us to find ways to maximize space to accommodate new users, and ensure our branches are equipped with the modern amenities our patrons deserve.

At Macomb's Bridge Library in Harlem, our smallest branch, we have secured a new location across the street that will allow us to more than quadruple the size of the much-needed library, plus create new spaces for classes and programs. Meanwhile, at our Washington Heights Library in Upper Manhattan, built in 1914, we completed a major renovation of the library's unused top floor in late 2016. Originally built as a caretaker's apartment, the longvacant space is now home to a welcoming Teen Center, finally giving neighborhood youth their own space at the branch. "Now teenagers have somewhere to

go after school," says María (p. 8), a junior in high school.

The Library is also preparing for full renovations at five historic "Carnegie" branches—Melrose and Hunts Point in the Bronx, Fort Washington and 125th Street in Manhattan, and Port Richmond in Staten Island. Currently in design, the upcoming projects were made possible by a \$100 million allocation in the City's FY16 Ten-Year Capital Strategy-which included funding for libraries for the first time. The increase followed a major advocacy campaign led by library users and supporters across the city that highlighted chronic underfunding for libraries. In all, there are an estimated \$1 billion in capital needs across the three library systems. A New Mid-Manhattan Library The Library is preparing for another major project that will improve and increase public space at two of our largest locations—Mid-Manhattan Library and the Schwarzman Building.

At Mid-Manhattan, we are planning for a full-scale renovation that will turn the aging former department store into the state-of-the-art central circulating library that New Yorkers deserve, including an adult education center and separate areas for kids and teens. Within the Schwarzman Building, we have increased storage and made other improvements (see p. 4), and plan to convert vacant and underused spaces to public use. Construction is set to begin at Mid-Manhattan in 2017.

WELCOME TO 53RD STREET LIBRARY



The Library's newest branch, 53rd Street Library, opened in summer 2016, creating a vibrant oasis for reading and learning in Midtown.

Located across from the Museum of Modern Art, the branch features three floors of circulating books and services, more than 70 public computers, and flexible program spaces for the library's growing array of public author talks and events. Designed by the awardwinning architects TEN Arquitectos, the modern building also includes a separate Teen Zone and Children's Room, allowing the library to host events for different age groups at the same time.

Library Manager Genoveve Stowell says the branch has become the neighborhood's "living room," providing much-needed public space, books, and programs to a range of users, from local residents to students. "We bring together a diverse and impassioned community in a space that is at once welcoming and inspiring," she says.

We are also continually finding new ways to connect our vast resources and collections to new audiences across the city and beyond.


More Books for Readers

Over the last five years, the Library has become a national leader in the effort to increase e-book access for readers of all ages, working with book publishers and the White House to expand the range of free e-books available to library users both in New York and across the country.

We are now building on these efforts, and in summer 2016 we released SimplyE, our new free e-reader app that makes downloading library e-books easier than ever. Available for iOS and Android, the app allows NYPL cardholders of all ages to explore and borrow the more than 300,000 e-books in our collections with just three clicks. The Library is also making the app's code available to other libraries nationwide, as part of our broader efforts to ensure expanded access to library e-books. The new e-reader, which also helps users find NYPL book recommendations, is an important step in meeting our users' surging demand for e-books.

In FY16, the Library circulated 3.5 million digital materials a nearly 100 percent increase from three years ago. "I can find so many books I need at the Library," says Ansar, above, a recent immigrant who attends ESOL classes at Bronx Library

Center and is excited about learning how to download e-books from NYPL.

In addition to SimplyE, the Library now offers more ways than ever to help readers of all ages discover their next book. These range from our popular new podcast on all things bookish—*The Librarian Is In*—to highlighted staff picks in our branches. Readers can also use the interactive book finder on our website, and they can even request personalized librarian recommendations by email or via Twitter.

Exhibitions & Programs

Over the past year, we brought our collections to life through

a range of thought-provoking exhibitions, including *Alexander Hamilton: Striver, Statesman, Scoundrel* at the Schwarzman Building. Meanwhile, the Library for the Performing Arts honored the 400th anniversary of the Bard's death with *Shakespeare's Star Turn in America*, and the Schomburg Center celebrated the American Negro Theatre's 75th anniversary with an exhibition honoring its legacy.

Highlights from our 2016 public programs include luminaries such as Jhumpa Lahiri and Margaret Atwood at LIVE from the NYPL as well as new series, including Art Talks, Scholar Room Talks, and For the Public.

Children's book author Johanna Hurwitz discovered the power of books on her frequent trips to the library while growing up in the Bronx.

Now, she wants to make sure all children have access to the same opportunity. "I want my books to be in libraries, because a library book can be read by 10, 20, or even 30 people," says Hurwitz, who became a children's librarian and has written 75 books.

With her late husband Uri Hurwitz, she established a charitable gift annuity with NYPL, which provides her with a lifetime fixed annual sum, after which the Library will receive the annuity's balance.



REPORT OF THE TREASURER

The New York Public Library is proud of its impact across New York City and beyond this year. Over the past fiscal year, the Library hosted 18 million visits and circulated 23 million items. We also welcomed a record-breaking number of program attendees—more than 1.8 million, a 28% increase from the previous year.

The Library's financial position entering FY16 helped us to better serve our patrons. We began the fiscal year with a City funding increase of \$16.4 million—the largest operating funds increase in the Library's history. In this fiscal year, net assets were \$1.263 billion on June 30, 2016 (vs. \$1.357 billion on June 30, 2015), reflecting a decrease of \$93 million, or 7%. This decrease is predominantly attributed to the decline of \$86 million in the endowment market value from the prior year. The increase in net assets over the most recent five-year period was 36%, and the market value of our endowment on June 30, 2016, stood at \$1.043 billion. The total long-term debt outstanding on June 30, 2016, was \$185 million, which is repayable as a 30-year bullet. The strength of NYPL's financials was validated by both Moody's and Standard and Poor's recent affirmations of the Library's credit rating.

The increased City funding has allowed the Library to continue strengthening our essential services across our 92 locations. In FY16, we created 140 new positions across our neighborhood branches, research libraries, and educational program areas; expanded operating hours; and continued to expand innovative new programs that were piloted in recent years.

This year, we launched our e-reader app, SimplyE, expanding and simplifying the public's access to the Library's growing e-collections, with more than 300,000 e-books available to download for free. Since FY15, we've increased early literacy program attendance nearly 32%, to 364,000 attendees. Program offerings include family literacy workshops, such as our monthly Bilingual Family Literacy Breakfast Program at PS 98, where one of our children's librarians from the Inwood branch gives parents of local Pre-K students tools to support their children's early learning skills. Seats in the Library's Out-of-School Time program increased 7%, to nearly 3,400. Our ESOL enrollment also grew nearly 27% from the year prior, with a total of 12,360 enrollees. And in three neighborhood branches, we launched the pilot program "Coder Games," which teaches teens the basics of computer programming and coding, allowing them to create their own computer games. This successful program will expand to approximately 20 branches in FY17.


We are thankful to the Mayor, Speaker, and the entire City Council—as well as for the outpouring of support for our spring advocacy campaign, mounted in collaboration with the Brooklyn and Queens library systems. As the Library continues with expanded hours, days, and access to informational resources, we will also continue to grow our educational programs in the coming years. All of this will require continued strong management of our financial resources and even more public support and philanthropic generosity from our donors and Board of Trustees.

BRANCH LIBRARY REVENUES (\$175,536,000)








RESEARCH LIBRARY EXPENSES (\$127,385,000)



SUPPORT THE NEW YORK PUBLIC LIBRARY RECOMMENDED FORM OF BEQUEST



The New York Public Library is a not-for-profit education corporation incorporated under the laws of the State of New York. The Library is exempt from federal income tax as an organization described in section 501(c)(3) of the Internal Revenue Code and is a publicly supported organization under section 170 of the Code.

Gifts and bequests to the Library are deductible under the federal income, estate, and gift tax laws. For federal tax purposes, the Library uses its formal corporate name: The New York Public Library, Astor, Lenox and Tilden Foundations (reflecting its incorporation by the consolidation of the Astor Library, the Lenox Library, and the Tilden Trust). The Trustees of the Library recommend that for estate planning purposes, friends consider the following language for use in their wills:

"I give and bequeath (dollar amount, percentage of residuary estate, or description of property) to The New York Public Library, Astor, Lenox and Tilden Foundations, Fifth Avenue and 42nd Street, New York, New York 10018, for the Library's general purposes."


If you wish to make a bequest for a specific purpose, it is suggested that you consider adding the following language to any restriction you may impose on your bequest:

"If at any time in the judgment of the Trustees of the Library, the designated purpose of this bequest proves to be impracticable or impossible, I authorize the Trustees to use the income and principal of this bequest for any purpose they deem to be consistent with the general intent and purpose set forth herein."

Should you decide to leave a bequest to the Library in your will, you will become a member of the Bigelow Society. Created by the Library in 1991, the Bigelow Society is an honorary organization whose purpose is to recognize the generosity of individuals, during their lifetime, who include this institution in their estate plans. The Library expresses its gratitude to members by inviting them to special Library events and by listing their names in donor publications under the Bigelow Society (unless donors prefer to remain anonymous).
